 - 2. It was **resolved** to authorise Cllr Smith to signal to Active Lincolnshire the Parish Council's wish to proceed to the next step of proceeding with a PlayZone area.

Appendix 1

Presentation on Playzones to Pinchbeck Parish Council by Cllr John Smith 15 July 2024

What is a PlayZone?

- Government initiative via Sport England, Premiership and the Football Association
- A community led space for healthy activity and sport to take place
- Supported by LCC and 3 District Councils via Active Lincolnshire
- 240 across the UK
- Majority in urban areas but needed in rural locations
- A huge opportunity for our residents

2. What does a Play Zone look like?

- Usually, a 30m x 20m space which is fenced and secure
- Can be astro or tarmac
- Usually linked or near to an administrative facility
- Designed and influenced by local need
- Developed to tackle health inequalities
- Used by local organisations, agencies and people

3. WhyPinchbeck?

- Pinchbeck meets many of the essential criteria and also has several positive attributes that could add value to any proposal.
- We are an area of high health need especially for people over 50 and disabled people.
- We have a large number of people in the lower socio-economic groups due to our local agricultural employment profile
- Our population has no similar facilities in the local area.
- As a Parish Council we have a good record of delivering projects and services.
- We have a good network of organisations and societies who could benefit from the PlayZone.
- We have good links with health and social care services.
- The Hub has potential to provide administrative support to the PlayZone.
- We have potential sites available for the PlayZone

4. Other reasons to choose Pinchbeck?

- There are several other reasons we are seen as a priority
- Proposed cycle path
- SME's and local employers

- Links with sports clubs
- Pinchbeck Youth Club and other Youth Movements
- 2 local schools
- 3 Health Centres that serve our population

5. What'shappened to date?

- Active Lincolnshire have commissioned some exploratory work via open tender process
- Along-list of sites have been identified
- 3 sites have been provisionally prioritised
- The FA have approved support to developing 3 or 4 sites in South Lincolnshire

6. What else could it help us achieve?

- Part of a longer-term strategy to improve health and wellbeing via community available facilities
- Could add other issues such as parking, widening access and participation, increasing range of sports and activities
- Gives a new purpose to the field
- Could act as a catalyst for further Sport England/FA investment
- Huge benefit to our residents
- Income generation

7. Whatnext?

- If we agree then Active Lincolnshire would
- Help support creation of a business case
- Assist us in getting the necessary funding
- Guide us through the process including consultation, planning and any other requirements
- Support the implementation
- Funding
- Usually 70% to 75% of cost if funded by FA
- 25% to 30% needs to be identified locally

8. What is the ask?

 That we as a Parish Council consider and discuss the potential benefits of having a playzone in Pinchbeck and give approval for further work to be completed in partnership with Active Lincolnshire to develop a more detailed business case.
